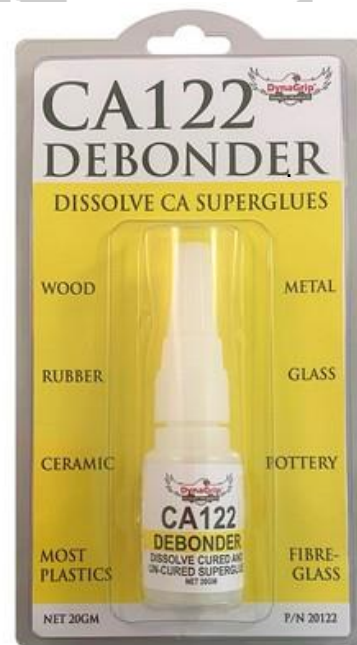

• NOTE: MAY ATTACK CERTAIN PLASTICS, PAINTED SURFACES, FOAM OR VARNISH. TEST IN AN INCONSPICUOUS AREA FIRST.

## DIRECTIONS:

CA122 DEBONDER works best under repeated applications rather than on excessively large application. Apply CA122 DEBONDER, allow it to dissolve hardened superglue and repeat as necessary.

To release bonded skin (not near eyes) apply CA122 DEBONDER, then use a small rounded object, like a paperclip, to separate the skin with a peeling action, applying more CA122 DEBONDER as needed. Wash the area with soap and water.

STORE UPRIGHT IN A COOL AREA AWAY FROM SUNLIGHT
